


National Summary Profile of Canada's Tourism Employees





The tourism sector in Canada in 2021 was still reeling from the aftereffects of the pandemic: employment was well below pre-pandemic levels, and visitor demand had yet to return in force. While this year was a non-typical year in many respects, it is nevertheless useful to understand where the tourism workforce stood at the time of the census, in May 2021.

In 2021, there were around 1.4 million Canadians working in the tourism sector, spread across its five constituent industry groups: Accommodations, Food and beverage services, Recreation and entertainment, Transportation, and Travel services. These individuals made up 8.0% of the entire employed labour force in Canada. This figure is substantially lower than in 2016, when 1.8 million people accounted for 10.6% of the labour force. Table 1 provides an overview of employment in key tourism occupations across these five industry groups.

The tourism workforce overall employed a greater share of young people, including students, and a larger share of the work was part-time and seasonal (see Table 2). Tourism also employed a larger share of immigrant and non-permanent resident workers and visible minorities, while its share of the Indigenous workforce was comparable to that of the larger economy. There were slightly more men than women working in tourism as a sector, although there were substantial differences at the industry level, with men being over-represented in Transportation, and women being over-represented in Accommodations, Food and beverage services, and Travel services.

There are two important considerations when looking at this data. The first is the historical atypicality of 2021: the sector has seen considerable growth since this census was conducted, although it has yet to fully return to pre-pandemic levels (with 2019 as a reference baseline for comparison). The second is that employment questions in the census pertained primarily to the week of May 2 to 8, 2021, meaning many seasonal occupations (either winter or summer) are likely to be under-counted.

⁵ Note that Statistics Canada has adopted a new statistical approach to defining women and men, where a certain proportion of non-binary individuals have been classified into either binary category. Although the difference in absolute numbers is very small, these newly-defined categories (identified by the + symbol) are not directly comparable to gender counts in previous censuses. For the sake of readability, *women*+ and *men*+ are referred to as *women* and *men* in the accompanying text.
